Mine identification signs are in place at all access points into the permit area from the public. The signs contain the required information.

Additional stream buffer zone signs need to be placed along the relocated Robinsons Creek adjacent to Pit #3.

22. Other

September 13, 2011

Mining in Pit #2 was taking place during the inspection. Pit #2 is nearing completion. Pit #3 overburden material was being stripped off in preparation for the seam to be mined. Coal was actively being shipped from the mine by double trailers and tractor.

September 14, 2011

Coal was being shipped, but mining was temporarily suspended due to wet conditions from rain storm.
