2. Signs and Markers

The mine identification sign is posted at the entrance into the mine site. The sign is visible and does contain all of the required information by regulation.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Pond #3 is approaching the level where it need to be decanted. Pond #2 is snow covered no observable water.

6. Disposal of Excess Spoil, Fills, Benches

A berm has been installed at the base of the excess spoil pile on the eastern side. The berm lies next to the fence line. Active placement of spoil material on the excess spoil was taking place durin the inspection.

8. Noncoal Waste

The area was free on noncoal waste material (trash) during the inspection.

13. Revegetation

A small of area has been seeded with an interim seed mix. The area is adjacent to the topsoil pile by DD-2 and DD-2a. This area has a road that leads to the topsoil pile and in the future a portion of that road will turn into a new haul road. The area that has been seeded is a potion adjacent to the future haul road that will not be needed to achieve the needed width of the haul road.

22. Other

Mining in Pit #3 is completed. Pit #5 is being excavated and a small portion is being actively mined. Pit #4 has not been stripped or mined yet.
