2. Signs and Markers

The mine identification sign is located at the access points into the mine permit area. The signs contain all the required information.

4.a Hydrologic Balance: Diversions

Additional rip rap has been placed into the Robinson Creek by-pass channel. There is still some sections left that rip rap needs to be placed in. There are may areas where the rip rap needs to fanned out or the bottom onto the walls of the channel.

6. Disposal of Excess Spoil, Fills, Benches

A portion of the excess spoil pile is covered with subsoil and parts of that area are also covered with topsoil. Work on the reclamation of this section was actively taking place during the inspection.

8. Noncoal Waste

Mine site was free of noncoal waste items.

20. Air Quality Permit

Road ways were being watered during the inspection. Some dust is being air bourn from the coal crushing and loading facilities.
