2. Signs and Markers

The mine identification signs are in place at all points of public access into the mining permit area. The signs were checked and contain the required information set forth in the Utah R645 Coal rules. The signs are compliant.

4.a Hydrologic Balance: Diversions

Culvert #11 referenced in the OSM inspection report as an action item has had material removed from the inlet side of the culvert. Some material still remains in the culvert. The operator plans to flush the culvert out to finish the maintenance.

The diversion (Ditch #4) that leads into pond #3 was viewed by the operator and the division inspector during the partial inspection. A scope of work was discussed to bring the diversion into the approved design criteria. The work will require a long stick track hoe which is currently located on site.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The inlet into Pond #1 was checked as a follow-up to the previous inspection with OSM. The inlet has been reworked and rip rap has been placed in the inlet. The drawing for pond #1 shows rip rap in this inlet. This concern has been taken care of. A picture of the inlet was taken and is included as part of the PDF version of this inspection report.
