2. Signs and Markers

The mine identification signs are posted at all points of public access and contain the required information.

4.a Hydrologic Balance: Diversions

Ditch #4 that leads into Pond #3 was walked during the inspection. The diversion is functional, but there are a few areas that were identified as needed some maintenance work. The areas were documented by the operator so that the work can be done.

The intersection point of the Robinson Creek bypass outlet back into the natural Robinson Creek (Southern end) needs maintenance. The area eroded from several back to back high intensity rain storms from the previous month.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

All sediment ponds were checked as part of the partial inspection. Pictures were taken and are attached to the PDF version of this inspection report. Water has been pumped down in ponds 1 and 1B. Water levels in ponds 2, 3 and 4 still remain relatively high from recent storm events. The emergency spillway on pond #3 requires maintenance work.

6. Disposal of Excess Spoil, Fills, Benches

The small erosional cut on the Northwest reclaimed face has deepened from the recent storm events and now requires repair. The measures taken before was the installation of wattles. The area will now need to be backfilled top soiled and re-seeded.
