Report summary and status for pending enforcement actions, permit conditions, Division Orders, and amendments:

The purpose of these two site visits was to inspect the mitigation work that had been contracted by Alton Coal on the 355 acre BLM parcel adjacent to the Coal Hollow mine. Access was limited on August 12th due to continuous rain from 12 AM to 10:30 AM the previous evening. Photographs and GPS coordinates were taken of the areas visited within the parcel. There is no evidence of additional treatment in the Northwest portion of the parcel. Treatment in the remaining portions of the parcel does not meet the specifications required by the BLM, DWR and DOGM, specifically the requirements noted in the BLM letter to DOGM dated 02/28/2014, incorporated into Appendix 3-7 of the Coal Hollow MRP. There are a few, very few piles of pinyon juniper that have received additional treatment that meet the required specifications. Additional treatment will be required to meet the specifications outlined in ACD's MRP by October 31, 2015.

A Sokkia level book measuring 6.5" in length was used as a scale in the photos taken on the 19th of August. Each photo of an opened level book indicates the end of photos taken at that GPS location.
