**Modified as follows:**  
 The timeline to provide complete and adequate plans for interim reclamation and stabilization of the cut slope in the borrow area and all other requested information for abatement of NOV 21183 is hereby extended to August 31, 2016. This allows only four working days to ensure the plans meet with Division approval before the 90 day abatement period ends on September 6, 2016. September 6 is 90 days from June 9, 2016, the date of receipt of the certified NOV 21183.

**Reason for modification:**

Plans required for NOV 21183 abatement are contingent upon receipt of complete and adequate reclamation plans for Pit 10/the underground mine. The reclamation plans for Pit 10 are the subject of NOV 21164 (written January 20, 2016). The abatement of NOV 21164 has twice been extended beyond the 90 day abatement period by the Division Director. The last extension provided until August 17, 2016 for receipt of plans and allowed 10 working days (until August 31, 2016) to ensure complete and adequate plans are approved.
