Dear Director:

In accordance with Part II-I-3 of our NPDES Permit UT0022918 and UMC 817.52(b)(1)(ii), we are notifying you of a noncompliance sample for our NPDES Discharge Point 003.

The sample collected June 7, 1990 had a reported TDS level of 1,516 mg/l according to Ford Lab Report 90-007272 which we received on June 25, 1990. This TDS value was much higher than previous TDS levels for outfall 003. We requested the laboratory to run a check sample on the reserve and the resulting TDS level was 836 mg/l. A copy of the faxed data sheet on the retest and the original is enclosed. The result of the second test shows that the TDS was 36 mg/l above the maximum allowable permit level of 800 mg/l. This sample was taken as part of our regular NPDES monitoring.
