Dear Director:

In accordance with Part II-I-3 of our NPDES Permit UT0022918 and UMC 817.52(b)(1)(ii), we are notifying you of a noncompliance sample for our NPDES Discharge Point 003. The sample collected June 20, 1990 had a reported TDS level of 814 mg/l according to Ford Lab Report 90-007500 which we received on July 10, 1990.

We believed that the test value was suspect and asked Ford Lab to recheck the values. On July 12, 1990 we were told by telephone that the recheck values for the June 20, 1990 sample were 776 and 784 for the two rechecks that were done. This is noted on the enclosed analysis sheet. When a new certificate of analysis was not issued, we called Ford on July 23, 1990, to find out why. At that time we found out that they had erroneously given us the results for the July 5, 1990 sample instead of the June 20, 1990 sample. The correct recheck value for the June 20, 1990 sample was 858 mg/l which is higher than the original.

Therefore the June 20, 1990 sample exceeded the permit limit of 800 mg/l for TDS.
