Company, National Mines Corporation, Virginia Iron, Coal
& Coke Company, and Wheelwright Mining, Inc.

Dear Mr. Kovacic:

On behalf of the Kentucky Resources Council or the National
Wildlife Federation (collectively "the Complainants") or both, we
have filed citizens complaints which allege that each of the
corporations listed above, or entities related to those
corporations through common ownership and control, have violated
the Surface Mining Act and applicable state programs by failing to
disclose their ownership or control of one or more specifically
identified contract operators. Over the past few weeks we have
received responses from you and informal review decisions from Nina
Rose Hatfield which construe the Complainant's allegations of
permit disclosure violations to question only those new permit
applications, applications for major permit revisions, or permit
renewal applications filed by the named corporation itself with the
state regulatory authority for Kentucky.

1 On August 3, 1992, the Complainants filed citizens
complaints against National Mines Corporation concerning operations
conducted by JOS Coal, Inc., W&C Coal Co., and G,S&M Coal Company,
Inc. On August 19, 1992, the Complainants filed a citizens'
complaint against Virginia Iron, Coal & Coke Company concerning
operations conducted by E&B Energy, Inc. On November 17 and 18,
1992, the Complainants filed citizens' complaints against Island
Creek Coal Company concerning operations conducted by Elm Coal,
Inc., Allen & Newsom Coal Co., Inc., Bruce Branch Coal Co., Inc.,
Ashley Mining, Inc., and West Fork Coal Company, Inc. On November
20, 1992, the Complainants filed citizens' complaints against
Wheelwright Mining, Inc., concerning operations conducted by Twin
Oaks Construction Co., Inc., Danny Johnson, Star Lite Mining Co.,
Blue Branch Construction Co., Inc., and Maple Leaf Mining, Inc.

Please accept this as formal clarification that the Complainants intend each of these complaints to call to OSM's attention permit disclosure violations committed by the named corporation or any related entity with respect to any document any of them have filed in response to any regulatory requirement for disclosure of related entities. Moreover, the Complainants' allegations are intended to question any submission by these corporations and their related entities, regardless of whether the document was filed in Kentucky or any other State.

The Complainants have reviewed the citizens' complaints filed in each instance, and they believe that each complaint defines the scope of the permit disclosure allegation as described above. Nevertheless, to the extent that you have construed any or all of the citizens' complaints to define a more limited scope for the permit disclosure allegation in each, please accept this letter as an amendment of each citizens' complaint to define the permit disclosure allegation to extend to violations committed by the named corporation or any related entity with respect to any document any of them have filed in response to any regulatory requirement for disclosure of related entities, regardless of whether the document was filed in Kentucky or any other State.

In light of this amendment, please re-evaluate each of the citizens' complaints described above and either (1) issue new or amended ten-day notices or cause your colleagues in other field offices to issue appropriate ten-day notices or both, followed by federal inspection and enforcement action as appropriate, or (2) issue a decision refusing to take some or all of such actions, explaining your basis for any such refusal. The Complainants have the right to file a single citizens' complaint with any appropriate OSM Field Office regarding permit disclosure violations which have occurred anywhere in the United States. Under the federal surface mining regulations, it is the duty of any OSM Field Office which receives such a complaint to co-ordinate the agency's complete response to permit disclosure allegations by involving the Applicant/Violator System Office and any other field offices whose actions may be necessary to address the alleged violation on a nationwide basis. Nothing in 30 C.F.R. §§842.11 or 842.12 suggests a geographical limitation on the scope of citizens' complaints, and the Complainants accordingly recognize no such limitation.

Please respond to this letter within the time allowed by the federal regulations, and please provide Complainants' counsel with copies of all actions which you or any other OSM office takes in response to this amendment. Thank you for your consideration of
