7. COAL MINE WASTE/REFUSE PILES/IMPOUNDMENTS

The permittee has spread and compacted the waste piles which were in place at the time of the October inspection. New piles have been dumped on the south end of the pad. Only a few pieces of noncoal waste were evident. There was no erosion or combustion evident. Fresh piles of coal mine waste have been placed in the temporary waste rock storage site (north of the noncoal waste storage area at the main site).


