### NOTICE OF DECISION

**SEVIER COUNTY**

Mesia Nyman, District Ranger, has decided to authorize Ark Land Company to occupy National Forest System lands to conduct a Coal Exploration Project on Federal Coal Leases U-64214 and U-76195 during September and October of 2003. The project will consist of three core holes drilled in the Pines Tract area of the Manti-La Sal National Forest. The project is located in Sevier County, T21S., R. 5 E., Salt Lake Base and Meridian. The drilling will occur on lands in which the surface is administered by the United States Forest Service and the subsurface by the Bureau of Land Management (BLM).

The three exploration holes, designed as 03-12-1 03-12-2, and 03-17-1, are needed to obtain geologic information on structure, ground water hydrology, and coal seam quality/thickness.

The Forest Service will issue a Road-Use Permit to authorize use of Forest Roads and will stipulate conditions needed to protect non-mineral resources.

This decision is not subject to appeal pursuant to 36 CFR 215.
