4.a Hydrologic Balance: Diversions

The retention berm located at the base of the NE corner of the Link Canyon substation topsoil pile has a small amount of freeboard remaining. This needs to be handshoveled to establish additional freeboard.

7. Coal Mine Waste, Refuse Piles, Impoundments

Quarterly refuse pile sample analyses were obtained for the first quarter of 2005 and the four quarters of 2004. This information has been forwarded to Ms. Priscilla Burton of the SL tech staff for analysis/review for the soils section of the midterm permit review process.

18. Support Facilities, Utility Installations

The lower Canyon containing the spring collection field, pump house, and leech field were inspected this day, as part of the ASCA evaluation for the midterm permit review process.
