## **1. Permits, Change, Transfer, Renewal, Sale**

The technical analysis for the Muddy Tract application was completed on July 29, 2005. Chris Hansen and Mike Davis requested a meeting to discuss the vegetation and wildlife deficiencies enumerated in the analysis. A copy of that document is included with this report. Suggested revisions to the vegetation, wildlife, and land use maps and relevant portions of the text were discussed. Additional clarification of ground truthing the vegetation map, plate 3-1, is needed. Mr. Hansen contacted Eric Duffin of Cirrus Ecological Solutions LC to schedule a field trip with their Biologist. A field tour is pending. A response to the technical analysis is tentatively scheduled for September 27, 2005.

### **4.d Hydrologic Balance: Water Monitoring**

Monitoring sites 303, 214, and 106 were photographed. GPS coordinates are being provided by Erik Petersen as the Division's GPS was not working. Mr. Petersen took samples and field measurements for these sites as well as flow measurements for the other monitoring points along the East Fork of Box Canyon.
