Dana, Steve,

One of the samples didn't get uploaded from the pipeline into the database or on the report. Sample UT0022918-003A, dated 3-8-06, CTE-59-28572.

The new sample site 1-8-1 parameters need to be changed in the EDI to not require a sample for the 1st quarter water monitoring like the rest of the Sufco wells, springs & streams. Sufco MRP requires "Monitoring sites are sampled three times per year" Page 7-48, Chapter 7 of MRP. This modification was approved in the MRP due to the sampling sites not being accessible during the winter months of the year. Maybe a text note referencing this page should be included at the bottom of Table 7-3, Page 7-44 to help clarify the requirements.

Also Sufco will need the other new sample sites for the SITLA Muddy Tract added into the EDI database for the 2nd quarter water monitoring data to be entered. Sites M-STR4, M-SP01, M-SP02, M-SP08, M-SP18, M-SP39, & M-SP53.
