2. Signs and Markers

The mine identification signs were in place at points of public access into the permit area. The signs contained the required information.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

New sediment pond is about 80% complete. The dike is constructed. The weir is oversized and a smaller one is on order. The discharge stand pipe still needs to be installed. Some re-grading is still left to be done along with seeding the area.

7. Coal Mine Waste, Refuse Piles, Impoundments

Refuse pile appeared stable.
