

2. Signs and Markers

The mine identification signs were observed at points o public access to several points of the permit area. The signs are all in good repair and contain the required information.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The new sedimentation pond construction is complete and the pond is in service. Water was diverted from the old pond into the new pond so that the sediment level could be checked in the old pond.

7. Coal Mine Waste, Refuse Piles, Impoundments

Refuse pile appears stable. No visible hazards were observed.

18. Support Facilities, Utility Installations

Work on uncovering the three old portals adjacent to the warehouse continues. Two of the three portals have been un-earthed.
