The Division is currently reviewing the South Fork of Quitchupah amendment, The North water spring amendment has been returned to the permittee and the company is putting together an amendment for a waste rock expansion area.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

Due to the large amount of waste rock associated with the 4th west portal development, the new conveyor is not operational. As noted in the permit section #1 an application to expand the current waste rock disposal site is being prepared.
