1. Permits, Change, Transfer, Renewal, Sale

As of the writing of this inspection report there were no amendments under review at the Division's office in Salt Lake. The company is preparing three submittals, one for pannel 3R 2S along Quitchupah creek, one for the waste rock expansion area and one for a processing and loadout facility located where the primary and secondary sediment ponds are. NEPA has been initiated at the proposed loadout facility and the company discussed the mining of 3R 2S with Division staff in Salt lake on 2/13. The waste rock expansion amendment is in progress.

4.d Hydrologic Balance: Water Monitoring

Water monitoring for the fourth quarter of 2012 has been submitted into the Division's database.
