1. Permits, Change, Transfer, Renewal, Sale

The Division received the as built drawings for the waste rock site subsoil pile and land ownership, lease and permit area, task # 4327. Text revisions to volume 3 of the MRP and plans to expand the current waste rock disposal site are scheduled for submittal to the Division in the next week or two.

3. Topsoil

The subsoil was double seeded in lieu of adding a mulch. This is an option noted in the MRP.

9. Protection of Fish, Wildlife and Related Environmental Issues

The mine personnel had removed two elk carcasses from the shoulders of the haulroad. DWR had been previously notified and had given the mine permission to remove the carcasses.
