1. Permits, Change, Transfer, Renewal, Sale

Conceptual designs for the blending facility were reviewed by the group. The proposed location adjacent to the new haul road was also visited. An EIS for this project will be required and is currently underway. Once that has been completed SUFCO will prepare an application to amend their current MRP to include the new blending facility.

2. Signs and Markers

New top and sub-soil signs have been placed appropriately at the waste rock site as high winds in the area had damaged the previous ones.

7. Coal Mine Waste, Refuse Piles, Impoundments

Plans to expand a small portion of the waste rock area (lift 5) are currently under review by the Division, task #4335 This area was also visited by the group.
