4.e Hydrologic Balance: Effluent Limitations

The UPDES ppermit is being updated to comply with the EPA's revised tonnage discharge limitations and is due by 12/14 to the DWQ.

7. Coal Mine Waste, Refuse Piles, Impoundments

SUFCO is in the process of developing plans for a larger waste rock site and possible wash plant. Some of the requisite surveys have been completed. An amendment to the current MRP may be submitted towards the fall of 2014.

9. Protection of Fish, Wildlife and Related Environmental Issues

The macro invertebrate study for the south fork of Quitchupa Creek was available for review and discussion at the mine office. A copy will be submitted to the Division for review.
