1. Permits, Change, Transfer, Renewal, Sale

The monitoring and mitigation plan, (Appendix 3-14), for undermining the south fork of Quitchupah 2R2S Block A and 3R2S Block B is found in volume 5 of the approved MRP. The steps for mitigating subsidence outlined in the plan were discussed with representatives from the mine. Division staff requested that the narrative describing the mitigation measures along with a map containing the gps coordinates and locations of the repaired area and monitoring points be provided to the Division by Monday, June 9th.

4.d Hydrologic Balance: Water Monitoring

The water monitoring locations 002 through 006 are scheduled to be monitored for flow as soon as possible to verify the ocular flow estimates above and below the repair area that have been provided to date.
