**8. Noncoal Waste**


The mine site was snow covered thereby making it impossible to evaluate if there was noncoal waste items outside of the designated containments.

**16.a Roads: Construction, Maintenance, Surfacing**


Roads leading to and within the mining permit area were snow covered and slippery. Snow removal on the roadways was occurring during the inspection. Numerous coal haul trucks were actively being loaded and hauling coal from the mine site.
