2. Signs and Markers

The mine identification signs at the sediment pond entrance, main facility entrance and the waste rock site entrance were observed during the partial inspection. The sign contain all of the information that is required to be posted on the signs.

7. Coal Mine Waste, Refuse Piles, Impoundments

Work was actively taking place on the waste rock pile. Compaction of the surface and slopes was being accomplished by using a bull dozer. Once the compaction is completed terraces will be cut into the out slopes. The current pile is nearing completion. Plans for covering the pile are in place.
