2. Signs and Markers

Identifications signs are posted at the sediment pond entrance, leach field, waste rock site and the main facility containing the name, address, phone number and mining permit number through the State of Utah. The signs are in compliance with the Utah R645 coal rules.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The main sediment pond sediment level is at 7,408.85'. The 60% sediment elevation is 7,408.10' The current sediment level is 0.75' above the 60% elevation. The sediment pond needs to be cleaned. The operator indicated that the pond would be cleaned in the spring. The 100% sediment elevation is 7,408.15.

7. Coal Mine Waste, Refuse Piles, Impoundments

The waste rock site appeared stable. No visible hazards were observed. The pile was being surveyed during the partial inspection.

16.a Roads: Construction, Maintenance, Surfacing

The main asphalt road way at the mine site was dry and dusty. Apprised the operators representative Amanda Richard of the problem. A call was made and water truck from the SR10 facility was dispatched.
