2. Signs and Markers

A new mine identification sign has been placed at the waste rock expansion site. The sign is consistent with the other identification signs throughout the site. All points of access into the mining permit area from a public road are signed in accordance with the requirements.

7. Coal Mine Waste, Refuse Piles, Impoundments

Construction is still taking place on the waste rock expansion area. The area is snow covered with a light snow covering.

8. Noncoal Waste

The mine site was examined and found to be free of noncoal waste items outside of an authorized containment.

The main roadways at the mine site had been watered to prevent dust emissions.
