1. Permits, Change, Transfer, Renewal, Sale

The current DOGM Permit for the SUFCO Mine C/041/0002 became effective on May 21, 2012 and expires on May 21, 2017.

The current insurance Policy GL6576428 is through National Union and Fire Insurance Co. Effective date is 02/01/16 and expires on 02/01/17. All required parameters have been met.

Reclamation agreement is dated 19 August 2015 and is signed by both parties.

SPCC plan is dated November 2011 and is signed, dated and stamped by a Utah P.E. on 11-9-11.

UPDES Permit UT0022918 became effective on October 1, 2011 and expires at midnight on September 30, 2016. There are three authorized outfalls.

Air Quality Permit N10665-0014 was issued on 1-28-13 and is still effective for the mine site.

2. Signs and Markers

Mine identification were found at all access points from the public into the mining permit area. The signs contained all of the information as required by regulation.

4.a Hydrologic Balance: Diversions

All diversions were snow covered from snow storm event that occurred yesterday.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The fourth quarter 2015 sediment pond and annual sediment pond inspection were conducted on 11/30/2015 and 12/10/2015. The reports are certified by a Utah P.E.

Construction on the new waste rock sediment pond area, phase 1 waste rock expansion area, is still taking place.

4.e Hydrologic Balance: Effluent Limitations

The discharge monitoring reports for December, November and October 2015 were reviewed during the inspection. The reports were submitted to DEQ.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was visited as part of the complete inspection. The pile appears stable. No visible hazards were observed in conjunction with the inspection.

The fourth quarter 2015 refuse pile inspection was done on 12/10/2015. The report was certified by a Utah P.E. on 12/14/2015.

20. Air Quality Permit

Approval Order #N10665-0014 from the Division of Air Quality was issued on 01/28/2013.

21. Bonding and Insurance

Bond is through Iron shore Indemnity Inc. Insurance Co. effective August 15, 2013. The bond was revised 08/19/2015 adding a rider to the original bond. The current bond is for \$3,944,000.
