2. Signs and Markers

Mine identification signs are in place at all points of access from the public into the mining permit area.

3. Topsoil

The topsoil and subsoil piles from the new waste rock site construction have been pocked with the addition of straw and then seeded. The slash piles are still on site. The material is still too wet to be burned.

7. Coal Mine Waste, Refuse Piles, Impoundments

The old waste rock site has been capped with subsoil and topsoil. The out slopes of this pile have been pocked with straw being mixed in and then seeded. The surface still needs to be pocked and seeded.
