### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**


Both sediment ponds at the main facility contained water at the time of the inspection.

## **8. Noncoal Waste**


The main mine site was free of noncoal waste items outside of the approved containment facility.

## **14. Subsidence Control**

As part of the partial inspection the large sink hole at the SUFCO Mine was visited. Work on the hole and the proposed repairs to the sink hole were completed approximately on October 5-6, 2016. The depth of the hole was significantly reduced and the sides were pulled in to create a bowl effect. The area has been pocked and seeded. Pictures of the completed work were taken during the inspection and are attached to the PDF version of this inspection report. Safety concerns for this site have now been alleviated.
