**4.b Hydrologic Balance: Sediment Ponds and Impoundments**


The main sediment pond and the overflow sediment pond located at the mine site both contained water at the time of the inspection. The ponds appeared stable. No visible hazards.

**7. Coal Mine Waste, Refuse Piles, Impoundments**


The waste rock site appeared stable. No hazards were observed. The expansion area is visibly starting to build in size.

**8. Noncoal Waste**


The site was free of noncoal waste items.
