2. Signs and Markers

The identification signs were all in place at entrances into the permit area from a public access point. The signs all contained the required information necessary to comply with the law.

4.a Hydrologic Balance: Diversions

Several diversions were checked during the partial inspection. All diversions inspected were open and functional.

7. Coal Mine Waste, Refuse Piles, Impoundments

No active hauling of refuse material was taking place during the partial inspection. The cable gate was up indicating that the site was not being accessed, The refuse pile appeared stable. No visible hazards were observed during the inspection.

8. Noncoal Waste

The mine site and waste rock site were free of noncoal waste items .
