2. Signs and Markers

Checked the mine identification signs for content and placement. All signs are located at the entrance into the mining permit area. The signs contained the name, address, phone number and mining permit number associated with the operator.

Topsoil piles are marked with topsoil signs. Permit areas are marked by perimeter markers.

8. Noncoal Waste

A skeleton crew was on the surface picking up items of noncoal waste items during the partial inspection.

13. Revegetation

Vegetative growth is present on the reclaimed portion of the old refuse pile. The area was covered and seeded last fall. The vegetative growth appears to be robust. A few thistle are present along the edges and should be removed to prevent them from spreading.

16.a Roads: Construction, Maintenance, Surfacing

Roadways at the main mine facility had been watered prior to the inspection to control dust. Roadways were damp upon arrival at the mine site.
