2. Signs and Markers

All of the mine identification signs have now been updated with the most current information. New address, phone number and company name. Stickers were made and placarded over top of the old outdated information. The signs are in compliance with the regulations.

4.a Hydrologic Balance: Diversions

Diversions at the mine site and waste rock site are snow covered.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The mine site and overflow sediment pond contained water. The sediment ponds at the waste rock site are snow covered.

7. Coal Mine Waste, Refuse Piles, Impoundments

The waste rock site was not active during the inspection. Area is snow covered, but the access road has been plowed. Some processing of the waste rock site has occurred to retrieve some coal from the waste stream. The pile appeared stable.
