The application meets the State of Utah requirements for R645-301-112 Identification of Interest.

The application identifies Bowie company name changes (effective 10/15/18) as follows:

Bowie Holdings, LLC became Wolverine Fuels LLC

Bowie Resource Holdings LLC became Wolverine Fuels Parent, LLC

Bowie Resource Partners, LLC became Wolverine Fuels Holding, LLC

Also included is an address and telephone number change for Canyon Fuel Company, LLC formerly Grand Junction Colorado and the Wolverine companies formerly Louisville, Kentucky to: 9815 South Monroe Street, Suite 203, Sandy, Utah 84070 (801) 695-9107.

General Chapter 1 identifies James Grech as the contact person and person who will pay abandoned mine reclamation fees, replacing Eugene E. DiClaudio who was released on 7/16/18.

Figure 1-1 and Figure 1-1B Organizational Charts were revised to update the Bowie company name changes to the Wolverine companies.

Appendix 1-1 (Organizational Ownership, Officers and Directors) was updated to reflect the release date (7/16/18) of Eugene DiClaudio as CEO/COO and the release date (9/12/18) of James Wolff as CFO. Appendix 1-1 was updated to reflect the appointment date (7/16/18) of James Grech as CEO and Marc Maglione (9/12/18) as CFO. The company name changes from Bowie to Wolverine were also updated.

The above-noted information was entered into the Applicant Violator System. An Evaluation of permit C/041/0002 was generated on 11/6/18 retrieving 17 violations in the system. Violations 1-17 are under Island Creek settlement.
