2. Signs and Markers

All identification signs for the SUFCO mine have been updated with the new address and phone number of the company. Even the signs located at remote access points into the permit area. The identification signs are in compliance with the Coal Rules pertaining to identification signs.

4.a Hydrologic Balance: Diversions

Diversions throughout the mine site are all snow covered from recent snow storm events. The diversions appear to be open and functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The mine sediment pond and the overflow mine sediment ponds both contained water. The sediment ponds located at the waste rock site were only snow covered.

7. Coal Mine Waste, Refuse Piles, Impoundments

At the time of the partial inspection the waste rock site was inactive. No material or work was being performed. The area is snow covered. The waste rock piles appear stable. No visible hazards were observed during the inspection.

16.a Roads: Construction, Maintenance, Surfacing

Roadways were damp or light snow covering. Main roadways were graded and allowed vehicular access.
