## **2. Signs and Markers**

Various signs were checked during the partial inspection.

Mine identification signs at the leach field, pump house mine site and associated entrances and the waste rock site were observed. These identification signs display the name, address, phone number and mining permit number as required.

Topsoil and subsoil signs were observed at the waste rock site where they are posted on the various piles.

### **4.a Hydrologic Balance: Diversions**

Diversions are open and functional as designed.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

Sediment ponds are dry with the exception of the main mine sediment pond and the overflow sediment pond, which contained water.

## **7. Coal Mine Waste, Refuse Piles, Impoundments**

Re-mining of the waste rock expansion area is completed. A stockpile of processed material remains on site and is slated to be removed. The processing equipment and screens have been removed from the site. The in place waste rock is graded and compacted as required.
