2. Signs and Markers

Checked the identification signs for content during the inspection. All signs display the name, address, phone number and mining permit number as required by law. The signs are in compliance. The sign at the Septic system site has been re-installed after the maintenance and is now more visible from the road.

4.a Hydrologic Balance: Diversions

Diversions were open and functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The waste rock sediment pond was dry. The main sediment pond and the overflow pond contained water.

7. Coal Mine Waste, Refuse Piles, Impoundments

No refuse material was being hauled to the waste rock site. The existing storage piles are stable and compacted. Some material from the re-mining of the site is still present and is stacked in a pile near the base of the expansion area.
