2. Signs and Markers

Identification signs for the mine site are placed at entrances into the permit area and contained the name, address, phone number and mining permit number. These listings are required by law. The signs are in compliance..

Topsoil piles contained signs indicating the storage of topsoil piles at various locations throughout the permit area.

4.a Hydrologic Balance: Diversions

Diversions are snow covered, but appear to be functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Ponds and embankments appear to be stable.

7. Coal Mine Waste, Refuse Piles, Impoundments

At the time of the inspection the waste rock site was inactive. The area is blanketed by a layer of snow. The site appears stable. No visible hazards were observed during the inspection.

14. Subsidence Control

Access to the recent subsidence areas that were identified in November 2019 is not possible due to snow cover leading to the subsidence locations. The mine site was aware of the subsidence and had surveyors plot the areas of subsidence and escarpment failure. The subsided areas fall under the approved subsidence plan. Access to this area will not be available until spring or early summer depending on the winter conditions.

22. Other

Recent work was performed on the leach field and the laterals contained therein. Prior to construction the area had been highly vegetated matching the surrounding vegetation relative to the elevation of the site. The construction stripped this existing vegetation to perform the needed repairs. However the area was scarified and re-seeded upon completion of the repairs. It is anticipated that regeneration will be successful, but the area will be monitored.
