2. Signs and Markers

The mine identifications signs at the septic field, pump house, road side, mine site and waste rock site were inspected as part of the partial inspection. All sign were found to be compliant by containing the name, address, phone number and mining permit number.

3. Topsoil

Topsoil piles and subsoil piles have signs on them to identify them and warn so that they will not be disturbed. All piles are presently snow covered.

4.a Hydrologic Balance: Diversions

Diversions are snow covered, but appear to be open and functional.

7. Coal Mine Waste, Refuse Piles, Impoundments

The re-mined material that was stock piled at the waste rock site has all been hauled and put into commerce. The waste rock site has several piles of waste stacked. As the area is completely covered with piles the lift will be leveled and compacted. The site showed no signs of visible hazards. The remaining pile appears to be well compacted.
