## **2. Signs and Markers**

The identification signs at the leach field and at the waste rock site were checked to make sure that they contained the required information set forth by regulations. Both of these signs contained the name, address, phone number and Utah mining permit number as required by law to be posted at the entrance into the permit area from a point of public access.

## **3. Topsoil**

The topsoil pile by the pump house has a sign to posted on it as required. Pile has a snow covering blanketing it.

## **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The main sediment pond at the mine site is scheduled to be be cleaned in the spring/summer of 2020.

## **7. Coal Mine Waste, Refuse Piles, Impoundments**

The waste rock site was not active during the partial inspection. The surface is covered by snow and the access is snow covered or muddy from snow melt. The pile appears stable. No visible hazards.
