2. Signs and Markers

The identification signs at the leach field, pump house and waste rock area were checked during the partial inspection. All of these signs displayed the required information to be compliant, i.e., name, address, phone number and permit number for the SUFCO Mine.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The main sediment pond cleaning is scheduled for next or early June.

7. Coal Mine Waste, Refuse Piles, Impoundments

The waste rock site was not active during the inspection. The current area is stable and compacted.

18. Support Facilities, Utility Installations

Access to the Main Mine site is limited due to repairs and maintenance work on the surface, due to these variables this area was not visited on this inspection.

22. Other

The leach filed area re-construction that occurred last year has now been re-seeded. Seeding of the area took place last week.

Access on top of the mountain is now available on a limited basis. Snow is still present. The area is not accessible by truck only by ATV's.
