December 7, 1977; March 29, 1978; May 2, 1978; and September 27, 1978.

Utah Coal and Energy Company, and all persons interested in said  
mining operation located in Township 3 North, Range 6 East, SLBM, Summit  
County, Utah, are hereby ordered to appear at the above scheduled hearing to  
show cause, if any there be, why the Board should not take the action as
