TOGETHER WITH a right-of-way and easement for purposes of stock watering and construction of a fence to facilitate said watering affecting and encumbering the following described two parcels of real property:

SUBJECT TO AND TOGETHER WITH a right-of-way for purposes of ingress and egress over and across a strip of property 24 feet in width lying 12 feet on either side of the following described line, to-wit:






